## SECTION I: MAJOR INCIDENTS

**Assault-Aggravated Domestic (UPDATE) 02/19/2019 400-blk Patrick La 2019-00514**

On February 19, 2019, 79 year old Thuan Tran was the victim of a domestic assault in his home in the 400 block of Patrick Lane. Tran was transported to the hospital with life threatening injuries and his wife, 77 year old Nhan Pham was taken into custody on scene and charged with malicious wounding. Mr. Tran, 79, passed away on Friday, February 22, 2019, as a result of the injuries sustained during this incident. Pham is currently being held without bond at the Fairfax County Adult Detention Center. Herndon Police detectives are currently working with the Commonwealth Attorney's Office to amend charges.

**\*\*UPDATE:** On March 18, 2019, the grand jury amended the charges to murder.

**Assault-Aggravated 09/19/2019 400-blk Herndon Parkway 2019-00810**

On Wednesday, March 20, 2019, Dennis Michael Markley, 29, of Herndon, VA, was arrested for felonious strangulation and misdemeanor assault of a victim that is known to him. He is currently being held without bond at the Fairfax County Adult Detention Center.
