The victim states that on Tuesday, June 18, 2019, shortly after 10:00 PM, he was going for a walk when two males approached him. The suspects tried to grab his cell phone and when the robbery attempt was unsuccessful, the parties took off running. The suspects are described as Hispanic males, approximately 19 years old. One is 6`1, skinny, and wearing a black hat to the back, black shirt and blue jeans. The second suspect is 5`6, heavy build, and was wearing a gray t-shirt and jeans.

The victim reported that on Friday, June 14, 2019, she was approached by a vehicle while she was walking down Vine Street towards Ferndale Avenue. The case is under investigation.
