### Burglary-Commercial

Shortly after 4:00 am on Sunday, July 7, 2019, officers were called to a commercial burglary alarm at the business. Video shows one suspect that presumably gained entry through a plexiglass window in the rear of the business that was broken using a cinder block. The suspect took an undisclosed amount cash from the register and 2 packs of Marlboro Gold 72 cigarettes. The suspect identified in the video, Wilson Manuel Navarro Escobar, 27, of Herndon, VA, was arrested on July 8, 2019 for burglary (F), possession of burglarious tools (F), petit larceny (M), destruction of property (M), and false identification to law enforcement (M). Navarro Escobar is currently at the Fairfax Adult Detention Center where he is being held without bond.
