SECTION I: MAJOR INCIDENTS

Assault-Aggravated **8/13/2019** **1000-blk Saber Ln** **2019-02674**
The victim and the offender, who are known to each other, were walking along the bike trail when the victim was assaulted. The victim sustained lacerations from broken glass as well as other injuries. Rescue was declined by the victim. The offender, Marian Acuna Palma, 26, of Herndon, VA, was arrested for aggravated assault. She was transported to the Fairfax Adult Detention Center where she was held without bond.

Robbery-Person **8/16/2019** **Elden St/Alabama Av** **2019-02727**
The victim reported that three to four individuals assaulted him and took the key fob to his rental car. The suspects stole the rental car, which was retrieved a short while later, just outside of town limits. The case is under investigation.

Burglary-Residential **8/16/2019** **1100-blk Arctic Quill Rd** **2019-02741**
The victim reported to police that the offender was seen on home surveillance cameras entering a locked safe in the home and taking various items, as well as taking a set of keys to a car parked outside of the home. A short while later, the offender was located, along with the stolen items and the vehicle. The offender, Brandon Jones, 20, of Herndon, VA, was arrested for unauthorized use of a vehicle and burglary. He was transported to the Fairfax County Adult Detention Center where he was held without bond.
